
### Methodology

This poll of 600 likely general election voters in Florida was conducted between July 31 and August 1, 2010.

All interviews were conducted via telephone by professional interviewers. Interview selection was random within predetermined election units. These units were structured to correlate with actual voter turnout in a general election.

The poll of 600 likely general election voters has an accuracy of +/- 4.0% at a 95% confidence interval.





#### Since Barack Obama won the election for President, who would you prefer to represent you in Congress?


- 1. A Democrat congressman who will help Barack Obama pass his agenda.

When a union wants to organize in a workplace, they must obtain approval from a majority of the workers. Under the current process, workers generally vote in a federally supervised private ballot election where a majority vote is needed to organize a union.
