#### Dear Employer:

It is my pleasure to provide you with this tabulation of the voting conduct of each member of the Florida Legislature during the 2023 Regular Session and Special Session A. The *Voting Records* reports on the votes made by every legislator on bills that were advocated, promoted, or opposed by Associated Industries of Florida (AIF).

By reporting on the 3,813 votes cast by legislators on 42 bills, this publication embodies the most exhaustive and complete record of the Legislature's approach to the concerns of Florida's employers.

We go to great lengths to ensure that legislators are aware of AIF's positions on issues of great importance to the business community. Every year before the session begins, we produce AIF's *Session Priorities*, which explains why we support or oppose key issues. In addition, during the session we provide each legislator with a *Weekly Brief* on the activities of that week, highlighting bills of interest to businesses and our positions on those issues. Our greatest asset, however, is our experienced and accomplished legislative team which has compiled a record of success second to none.

For 49 years, AIF has published *Voting Records*, yet these records only tell part of the story. AIF also helps its member companies detect which bills and amendments are filed and by whom, and who is taking part in behind-the-scenes efforts and debates on behalf of the business community. These intangible forms of support through non-voting actions are also of vital importance and merit recognition. AIF instituted the **"Champions for Business"** awards in 2003 to acknowledge lawmakers who provide leadership on key legislation.

A **"Champion for Business"** is a legislator who takes risks for his or her belief in the free-enterprise system, who defies the status quo when it is harmful to our state's competitive climate and faces down the opponents to the growing prosperity of Florida's citizens. Each of the six legislators (see page 14) honored this year are the epitome of a **"Champion for Business."**

# **Recognizing Top-Tier Issues**

Highlighting top-priority issues helps provide context for Voting Records.

Since 1975, AIF has published *Voting Records* — the definitive legislative scorecard for the business community. From a mathematical perspective, all votes cast are equal. The *Voting Records* compares the votes cast in support of business to the total number of votes cast on those bills. The calculated percentages are a simple and easy tool used by both AIF members and legislators.

However, although the AIF *Voting Records* considers each vote equal, it is clear that some issues rise to the level of being considered a "Top-Tier Issue". From time to time, an issue is taken up that affects the majority of all Florida businesses regardless of industry, size, location, etc. Issues such as workers' compensation, across the board business taxes and broad regulatory schemes are always top priorities for AIF. Just last year, we recognized that consumer data privacy was a top-tier issue due to its wide impact on a broad swath of the business community.

This year, AIF identified tort reform as the top-tier issue for the 2023 legislative session. Leading up to session, we hosted a business forum dedicated to the topic as well as highlighting tort reform as the top-tier issue in our *Session Priorities* publication. Additionally, we made it a point to communicate the importance of this top-tier issue in our daily and weekly briefings, as well as in public testimony.



Because of the importance of this issue, we are highlighting the specific vote on this top-priority issue (page 4) so the business community is able to clearly see how each legislator voted on this critical issue. This ensures that we have communicated to the business community both the overall vote % on all AIF selected business issues and the key votes cast on top-tier issues for each legislator.

We have immense respect for the dedication of elected officials who come to Tallahassee each year to serve the citizens of their districts and the state, and we applaud those legislators who consistently vote in support of Florida's employers. Yet, a simple voting percentage does not always provide a complete picture of a legislator's support of the business community.

Because of the level of importance of the tort reform issue to the entirety of the business community, we believe it is important to highlight how individual legislators voted on this issue to provide further context for our overall voting records.

AIF will continue to evaluate the effectiveness of each legislator through their overall voting percentage, their votes on specific top-priority issues, as well as how they publicly address issues that are important to the business community. All of these factors are considered when AIF makes recommendations to our members as to which legislators truly show strong support for Florida's business community.

## 2023 Session Top-Tier Issue: Tort Reform



Tort reform was the top priority for AIF and its members during the 2023 session due to its far-reaching impact on all sectors of the state's business community. The two main bills dealing with the tort reform issue were **HB 837** and **SB 236**. These bills took a giant leap in correcting an unfair and unbalanced legal system for employers.


# 2023 Florida Legislature *by the Numbers* **on Key Business Issues**

















#### Republicans by Chamber


