a letter from the CEO

Dear Employer:

The Constitution Revision Commission or the CRC, as the Commission is often referred, is incredibly important to both the business community and all Floridians. Made up of 37 appointees, the CRC has the power to add any proposed amendment to the Florida Constitution directly to the 2018 General Election ballot. There are no legislative committee hearings or debates, and no possible vetoes to prevent the Commission's proposals from being added.

This will be the third convention of the CRC, with the first one convening in 1977-78 and second in 1997-98. In the historical recap section (Page 5) of this guide, we have provided examples of the type of issues that have been sent directly to Florida voters—issues relating to our education system, taxes, firearms and the system to elect judges, to name a few.

As the statewide public hearings have now started and the Commission is rightfully receiving feedback directly from citizens, all possible issues may be considered. Florida's employers must pay attention, get involved, and make their voices heard in this process, just as we do with the Legislative, Executive and Judicial branches. We must guard against corrupt proposals that would harm Florida's business climate. Proposed amendments such as unfair taxes, burdensome regulations or extreme environmental policies could be placed on the ballot and be approved by voters on election day, leaving employers to deal with the dire consequences. Further, if they chose, the Commission could change a current part of the Constitution that is beneficial to the business community—possibly a section that we all count on for the continuation of employers to prosper here in Florida.

AIF has long history of being involved with the CRC on behalf of the business community and will continue to lead in this effort. I am proud to announce that we have formed the 2017-18 AIF Constitution Revision Commission Working Group to be comprised of some of Florida's most prestigious business leaders, as well as those with experience with past commissions.

What is the Constitution Revision Commission (CRC) and Why is It Important?

n 1968, the Florida Legislature created the Constitution Revision Commission (CRC) that would meet every 20 years to make changes and additions to the state Constitution. Made up of 37 Florida citizens, this Commission is the only one of its kind in the nation. Through a series of public meetings, issue research by appointed subcommittees and thorough discussions, the Commission drafts proposed changes to the Constitution for inclusion on Florida's general election ballot.

The Commission is made up of the following appointed or automatic members:

- The Governor appoints 15 commissioners and selects the CRC chair;
- The President of the Florida Senate and the Speaker of the Florida House of Representatives each appoints 9 commissioners;
- The Chief Justice of the Florida Supreme Court appoints 3 commissioners; and
- The Attorney General of Florida holds a seat on the Commission.

The commissioners come from varying locations, occupations, gender and race, bringing diverse views of Florida's guiding document. The work of the Commission will be ongoing for one year, during which time they will travel the state gathering public input and researching issues, ultimately drafting proposed constitutional amendments to be placed on the ballot. The public will then vote on those amendments during the elections, where each proposal requires approval by 60% of the voters to pass.

Why Is It Important?

The CRC has unique authority that can and has made a major impact on the laws in this state. The mere fact of making law directly in the state Constitution rather than going through the hurdles of normal state law gives this Commission a high degree of power. The usual legislative process has layers of checks and balances for proposals to become state law with multiple committees holding hearings in both the House and Senate, an amendment process and vote by each chamber, followed by the final hurdle of approval or veto by the Governor. Along with proposing additions to the state Constitution, the CRC may also remove portions of the Constitution that serve no purpose. Once the CRC goes through its process, its proposals are put directly on the general election ballot for a vote by the public.

There are other restraints that the legislative process has that the CRC doesn't, such as a single subject requirement which can allow the Commission to group proposals together regardless of the subject matter. Moreover, unlike proposed laws from the legislature, there is also no judicial review in place, which again means the CRC has incredible singular power to place whatever proposal the 37 members choose to directly appear on the ballot.

With these unique powers possessed by the CRC, the Florida business community must be aware that those who oppose the free enterprise system and who do not believe that a strong business environment is paramount to the success of Florida will be front and center at every public meeting seeking to get unfair legal issues, burdensome regulations and extreme environmental policies into state law.

History of the Constitution Revision Commission







he Florida Constitution Revision Commission was created in 1965 (Ch. 65-561, Laws), culminating a movement begun with a 1947 publication by The Florida Bar — *A Proposed Constitution for Florida*. Composed of 37 members, the Commission was created to prepare recommendations for the revision of the 1885 Florida Constitution.

The Commission first met in December 1965, with the full Commission meeting from November 1966 to January 1967 to create the final draft for the Legislature. The Constitution was passed by the Legislature in July 1968 and ratified by the electorate in November 1968.

1977-1978 Constitution Revision Commission

Chaired by Sandy D'Alemberte, this Commission had eight proposals on the ballot for voter consideration. Although none of the proposals passed, some were implemented later by ballot initiative or legislative proposal.

A sample of the issues that this Commission placed on the ballot included:

- A revision to provide that no person will be deprived of any right because of gender;
- The elimination of the Florida Cabinet (then composed of a secretary of state, attorney general, comptroller, treasurer, commissioner of agriculture, and commissioner of education) in January 1983;
- Revisions to the process of the selection and retention of Circuit and County Judges; and
- A modification that the State Board of Education be appointed by the governor and confirmed by the Senate.

1997-1998 Constitution Revision Commission

Chaired by Dexter Douglass, this Commission held 11 public hearings across the state and received nearly 200 proposals from the public. Ultimately, nine revisions were selected by the CRC to be placed on the 1998 ballot. Florida voters passed eight of those amendments in 1998, when only a simple majority of more than 50 percent was required for passage.


A sample of the issues that this Commission placed on the ballot included:

- The creation of the Fish and Wildlife Conservation Commission:
- The declaration that the education of children be a fundamental value of Florida;
- Restructuring the State Cabinet;
- Revisions to local and municipal property tax exemptions;
- Revisions to ballot access requirements of independent and minor party candidates; and
- The implementation of a required criminal history and records check for firearm sales.

The only proposal that was not approved by the voters dealt with local and municipal property tax exemptions and citizen access to local officials. It narrowly failed with 49.8% of the vote.




