
RELEASING OUR PRIORITIES

KEY VICTORIES DURING THE LEGISLATIVE SESSION



Significant Reforms to the Healthcare System


The legislative package referred to as the "Live Healthy Package" made significant reforms to Florida's health-care system by establishing new programs for the training and development of new professionals in the healthcare industry. Some of the initiatives provide for student loan assistance, expanded telehealth services, and the Interstate Medical Licensure Compact that allows licensed healthcare professionals from other states to practice in Florida. The Live Healthy package will invest almost \$1.2 billion to greatly expand Florida's healthcare workforce and provide innovative solutions to the shortage of desperately needed healthcare professionals.

Employment Regulations

Some local governments have enacted or proposed ordinances that create a patchwork of regulatory requirements and exceed other state and federal requirements. Several bills worked to standardize these regulations with regard to both minimum and prevailing wages as well as worker heat protection ordinances. Measures during the 2024 session promoted free market principles and ensured consistency by prohibiting local governments from having any control over the wages or benefits of businesses doing business with the local government. They also support regulatory consistency in workplace safety regulations that prevent a patchwork of local heat ordinances that could include unattainable standards which do little to protect employees while opening an onslaught of fines, penalties, and other punitive measures.

Beginning the Implementation of AI in Florida

A new law created the "Government Technology Modernization Council." This council, composed of executive branch agency heads, along with members appointed by the Governor, Senate President, and Speaker of the House, will oversee and advise the Governor and the Legislature on Florida's rollout of Al in state government and the private sector. AlF supports the increased dialogue at the state level about the beneficial elements of Al and how it can have a positive impact on Florida businesses. While creating proper boundaries and guidelines surrounding Al is important, it is also vital that the beneficial uses and innovation created by the proper use of Al are not unnecessarily stifled.



50th Anniversary of the AIF Voting Records

AIF was pleased to present the 50th edition of the Voting Records in 2024. AIF was the first and, for many years, the only business group to deliver such information to Florida employers. The purpose of the report is the same now as it was 50 years ago, to provide the business community with a metric to determine if a legislator supports businesses with the power of their vote. This year's report covered 2,498 votes cast by legislators on 33 bills, making it the most exhaustive and complete record of the Legislature's approach to Florida employers' concerns.

Over the last 15 years, every major issue of concern to our many companies has been addressed through the success of the AIF policy councils and their broad reach across many industries.



AIF Leads the Way on Artificial Intelligence for Florida Business

In early February, AIF announced that it was creating the Coalition on the Future of Artificial Intelligence for Business. The Coalition will lead the way for the business community in tackling this emerging critical issue for employers.



Coalition Mission

Bring business sectors together to:

- (1) develop guidelines for accountable and innovative Al policies and
- (2) educate and engage with policymakers to ensure a responsible regulatory structure.

There is strong consensus among elected officials and business leaders in the United States that thoughtful measures are necessary to prevent bad actors from using AI to impose harm to others or threaten our national security. As we consider proposals for legislation or regulation, it is critically important that policies continue to foster innovation and promote the adaptation of emerging technologies.



AIF's Center for Political Strategy is a culmination of listening to the needs of our members and Florida's top employers. Their desire was for a robust, complete, and comprehensive political entity that could improve the political landscape for the business community. The goal is to ensure that pro-business candidates, Republican or Democrat, are elected to the Legislature so that legislation which supports employers, not harm them, can be achieved.

Staying in-the-know on Florida politics is no longer an every other year effort. New data, shifting demographics, and Special Elections all require Florida businesses to be educated on the very latest information all year, every year.



What we are doing here at AIF in the political arena for our members is practically unparalleled in any other state. This is not a short-term plan. The Center has a long-term vision for the business community's political efforts.





Candidate Interviews

During the 2024 election season, the AIF Political Council held candidate interviews across the state and interviewed over 200 candidates for the Florida Legislature. Members of the Council were able to hear the position on key business issues directly from the candidates.

Quarterly Briefings

The Center held quarterly briefings for members to provide the latest intel and data on Florida's political landscape.

Polling & Focus Groups

The Center did statewide quarterly polling and focus groups throughout the year to monitor the mood of the electorate in Florida on both candidates and issues.

On the Ground Efforts

The Center not only interviewed candidates and gathered key data from polling, it also did direct on the ground efforts in key districts where candidates that supported Florida employers were being attacked. The efforts included strategic polling, campaign contributions via our PAC's, campaign mailers and coordinated efforts with our members and the candidates.



The Florida Water Forum



AIF was proud to host the 2024 Florida Water Forum,

the 14th edition of the event, in Orlando, Florida at Rosen Shingle Creek. Like past Water Forums, attendees were privy to a broad array of specifically tailored panels that cover the most important topics relating to Florida environmental/water policy. The goal every year at the Water Forum is for AIF to provide an effective platform for policy leaders and stakeholders to gather and learn about the impact these issues have on Florida businesses and the environment.

We were honored to have Florida's Commissioner of Agriculture, Wilton Simpson, join us for a fantastic keynote address to our audience and give an update on the Department of Agriculture's role in maintaining a sustainable blueprint for agriculture to thrive in sidestep with the environmental necessities needed to sustain Florida's precious natural resources.

Our panels touched on several topics including, nutrient management, agriculture, water industry trends, Lake Okeechobee, budgetary solutions to Florida's water infrastructure, resiliency, smart watersheds, and water quality.
